

ORDINANCE NO. 84

AN ORDINANCE TO AMEND ORDINANCE NO. 29 PASSED BY THE VILLAGE COUNCIL OF THE VILLAGE OF MAPLE RAPIDS, MICHIGAN ON APRIL 1, 1966, ORDINANCE NO. 59 PASSED ON DECEMBER 7, 1988, AND ORDINANCE NO. 74 PASSED ON MAY 7, 2003 KNOWN BY THE WATER SUPPLY DISTRIBUTION SYSTEM ORDINANCE OF THE VILLAGE OF MAPLE RAPIDS.

THE VILLAGE OF MAPLE RAPIDS ORDAINS:

Section 4. The rates charged for water services furnished by the System shall be as follows:

WATER USE CHARGES

Water use charges to each single-family residential premises served by the System shall be based on the chart shown below. Beginning January 1, 2019. Each premises other than single-family residence that share a meter shall pay a minimum of the 8,000 gallons multiplied by the total number of available units. Any additional gallons above the required minimum will be billed at the additional rate per additional 1,000 gallons. Any water services outside of the Village Limits shall be billed at 150% of the Village Rates. Bulk water sales rates will be based on each individual bulk water purchase. Municipal billing fees will be assessed for each applicable address based on base rates only and will not be charged the additional rate charges. Residents that reside part of the year out of state (Snow Birds) may freeze their service as long as prior arrangements are made with the Village Clerk.

TAP CHARGES

Water Tap charge rates shall be \$1,500 for the tap into the existing water line. The Village of Maple Rapids will provide a material list for parts that the homeowner must purchase to complete the water service. Installation shall be completed by an authorized contractor. An additional \$1,000 will be charged for each road cut. Extensions of existing water lines will be paid for by the affected customer. All work not performed by the Village of Maple Rapids DPW shall be performed by a bonded and insured contractor.

If any section, paragraph, clause or provision of this Ordinance shall be held invalid, the invalidity of such section, paragraph, clause, or provisions shall not affect any of the other provisions of this Ordinance. All Ordinances, resolutions or orders, or parts thereof, in conflict with the provisions of this ordinance are to the extent of such conflict hereby repealed.

This ordinance shall be effective 30 days after its passage by the Village Council.






